





# **IBS PRIMActu<sup>™</sup> TILE UNDERLAY**

### PURPOSE

IBS supply PRIMActu panels for use as:

- > an underlay for ceramic or other tiles
- > a base for waterproof membranes and screed.

### **EXPLANATION**

PRIMActu is a fibre cement flooring underlay. The panels are manufactured from cellulose pulp fibre, finely ground sand, Portland cement, and water.

Each panel has a smooth, sanded, and sealed face.

Panels are supplied with a pre-marked nailing pattern.

Available panel sizes as follows:

- > Length (mm): 1800
- > Widths (mm): 900, and 1200
- > Thickness (mm):

# Limitations

> BRANZ recommends that

- floor joist spans should be 20% less than what is specified in Span Table 7.1 NZS 3604:2011
- PRIMActu is not installed until the flooring and timber framing is dry enough to ensure the majority of shrinkage has occurred.
