Application Guide

Surface Preparation

• Note: Fill holes and imperfections with a suitable timber putty if required.

BARE TIMBER

Allow timber to weather for 4-6 weeks.

For exterior surfaces, clean with Cabot's Deck Clean following label instructions.

PREVIOUSLY PAINTED OR VARNISHED TIMBER

Remove back to bare timber using a paint stripper, or sanding. For exterior surfaces, clean with Cabot's Deck Clean following label instructions.

PREVIOUSLY STAINED OR OILED TIMBER

For exterior surfaces, clean with Cabot's Deck Clean following label instructions. Test if the surface is ready for coating by sprinkling water on the timber. It the water beads on the surface, repeat the application of Cabot's Deck Clean. If water is absorbed into timber, it is ready for coating. For a more transparent look, sand timber back to bare then clean with Cabot's Deck Clean before coating.

WEATHERED AND GREY TIMBER

For best results, sand timber back to fresh substrate. Clean with Cabot's Deck Clean following label instructions.

Application Procedure And Equipment

APPLICATION

Stir thoroughly with a broad flat paddle before and during use When using multiple tins we recommend boxing to achieve a uniform consistent colour.

Apply liberally along the length of the board including exposed edges and end grain by brush or pad applicator. Thoroughly work the coating in and around nail heads to ensure that a good seal is achieved. Allow the first coat to dry and then apply a second coat using the same method. Continue applying coats until you achieve the depth of colour you desire.

Work in manageable sections. Always coat to a natural break. Do not stop mid-section as this will create lap marks. Always work along the grain, never across, and maintain a wet edge.

lay off the coating in the direction of the grain using long soft strokes, to ensure an even finish and to reduce brush marks.

Always work out of direct sunlight. Timber being coated should be dry and cool to the touch.

Follow all other good coating practices.

MAINTENANCE

Re-apply as the timber changes colour or when water repellency diminishes due to weathering. Follow surface preparation instructions. To achieve a deeper colour or more opaque finish, further coats can be applied

In hot temperatures do not apply in direct sunlight, cool the timber by lightly dampening with water and coat in the shade.

Can be walked on 16 hours after final coat.
