Surface Preparation	<ul> <li>Note: Cabot's Floor Clean should not be used on fresh coatings that are less than 72 hours old.</li> <li>Ensure surface has been cleaned with a duster or dust mop prior to using Floor Clean so as to remove loose particles of dirt.</li> </ul>	
Application	<ul> <li>Add approximately 50mls of Floor Clean concentrate (2 capfuls) to 4 litres of water.</li> </ul>	
Procedure	Apply Cabot's Floor Clean to the floor with a mop to loosen grime and dirt. Do not flood the floor with cleaning solution. Return excess
