## CONDITIONS OF WARRANTY:

This warranty is strictly subject to the following conditions:

- a) A "defect" in respect of the Product means a non-compliance with AS/NZS 2908.2.2000
   Cellulose-cement products Flat sheet.
- b) All warranties and indemnities offered by ETERNIT® are only applicable to products sold within New Zealand.
- c) The warranty is subjected to the client following ETERNIT® instructions for the installation and maintenance of the panels and allowing access for inspection as required.
- d) The installer of the panels certifies that they have been installed in accordance with ETERNIT® specifications.
- e) The client must notify ETERNIT\* in writing of any defect occurring during the warranty period, within 30 days after the defect have become reasonably apparent or if the defect was reasonably apparent prior to installation, then the claim must be made prior to installation. The client must provide proof of purchase of the product.
- f) This warranty cannot be relied upon by any other person and is not transferable.
- g) The project must be designed and constructed in strict compliance with all relevant provisions of the current Building Code of New Zealand, regulations and standards.





- h) This warranty does not apply where the Product has been used in any manner not in accordance with the ETERNIT® instructions (including applications of the product above 12 meters from ground level), nor the reuse of the Product after its initial installation. This includes installation and maintenance in accordance with ETERNIT® literature current at the time of installation and must be installed in conjunction with the components or products specified in the literature.
