#### c. Backing - ecoBack

Fully recyclable polyolefin-based carpet tile backing. The polyolefin-based layer has minimum 75% recycled content.

# 2. Manufacturing

#### a. Renewable energy

49% of our energy consumption is electricity. The electricity that we use at modulyss is 100% 'green electricity' generated from renewable resources such as our own solar panels.

#### b. Production site & process

modulyss runs an integrated production chain: from tufting to the packaging of the finished tile.

#### ISO certification

Our production site is **ISO-9001** certified (Quality Management) since 2000 and ISO-14001 certified (Environmental Management) since 2009.

We've partnered with  $CO_2$ logic, to make sure  $CO_2RE$  delivers a long-term sustainable model for our offsetting. We currently sponsor a climate project that is in line with the PAS2060, an international standard which regulates the  $CO_2$  offset-requirements.
